



**Junior Assistant /Bill Collector/Field Assistant/Store Keeper posts

The candidates whose register numbers as mentioned below have been provisionally admitted to Physical Certificate Verification-cum Counselling to the posts mentioned above based on the marks and rank position hosted in the Commission's website on 24.03.2023, for which the written examination was conducted by the Commission on 24.07.2022 FN. The Physical Certificate Verification-cum- Counselling for the posts of Junior Assistant / Store Keeper included in Combined Civil Services Examination – IV (Group-IV Services Notification No.07/2022, dated 30.03.2022) will be held from 03.01.2024. The Physical Certificate Verification-cum-Counselling will be held at the Office of the TNPSC, No.3, TNPSC Road, Chennai - 600 003.

Individual intimation regarding the date and time of Physical Certificate Verification-cum- Counselling will be informed through Commission's website, SMS and e-mail only. Individual intimation will not be sent to the candidates by post.

The candidates with the following Register Numbers are admitted to Physical Certificate Verification-cum-Counselling and his/her admission to Certificate Verification and Counselling is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Educational Qualification, Experience, etc. Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to Counselling. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Counselling will be cancelled.

- i. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Physical Certificate Verification-cum-Counselling.
- ii. The candidates whose Register Numbers mentioned in the above list have been admitted provisionally to the Physical Certificate Verification-cum-Counselling based on the particulars furnished by them in their online application, overall rank obtained by them in the Written Examination and with reference to the Rule of reservation of appointments and Number of vacancies.
- iii. The candidates who had appeared for written examination on 24.07.2022 FN and had uploaded the documents for Onscreen Certificate Verification and whose register numbers are not found in the above list have not been admitted to the II-Phase of Physical Certificate Verification-cum-Counselling as their applications have been rejected for various reasons/they did not reach the zone of consideration when short listed in the ratio fixed for Physical Certificate Verification-cum-Counselling.
- iv. After verification of original certificates, the eligible candidates alone will be admitted for the counselling to be held on the same day.
- v. The candidates can download their Memorandum for Admission to the second phase of Physical Certificate Verification-cum-Counselling from the Commission's Website and should attend the Physical Certificate Verification-cum-Counselling with all the relevant documents in original on the prescribed date and time without fail. Candidates who have

failed to attend Physical Certificate Verification-cum-Counselling on the scheduled date and time will not be given another opportunity and will not be considered for the next stage of selection.

- vi. The provisional admission of candidates to Physical Certificate Verification-cum-Counselling does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
- vii. The admission of above candidates for Physical Certificate Verification-cum-Counselling is purely provisional subject to the outcome of writ petitions, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment.
- viii. Candidate's option at the time of counselling is final. Request in respect of change of Department/ Unit will not be accepted under any circumstance at a later stage.
